4.2 Draft SR-241 TCM Substitution Emission Analysis

Anup Kulkarni, OCTA, reported the following:

- OCTA initiated TCM substitution for SR-241 extension project with SR-241/SR-91 connector project in December 2015.
- OCTA staff had modeled three alternatives using Orange County Transportation Analysis Model (OCTAM): No Build, SR-241 extension project, and SR-241/SR-91 connector project.
- EMFAC2014 was used to calculate summer emissions for ROG and NO_x, winter emissions for NO₂ and CO, and annual emissions for ROG, NO_x, PM₁₀, and PM_{2.5} for three milestone years 2021, 2031, and 2040.
- Draft analysis demonstrated that SR-241/SR-91 connector project provided equivalent emission reduction benefits as SR-241 extension TCM.
- Final emissions analysis will be presented to TCWG when available.

In response to a question, Rongsheng Luo, SCAG, confirmed that TCWG would have two weeks after today's TCWG meeting to comment on Draft SR-241 TCM Substitution Emission Analysis as indicated in his email to TCWG on July 25, 2016.

4.3 FTIP Update

John Asuncion, SCAG, reported the following:

- All 2015 FTIP Amendments had been approved.
- Draft 2017 FTIP was approved by SCAG's Transportation Committee on July 7, 2016 and subsequently released for a 30-day public review from July 8, 2016 through August 8, 2016.

4.4 RTP Update

Daniel Tran, SCAG, reported the following:

- California Transportation Commission had released Draft 2016 MPO Regional Transportation Plan Guidelines for a 30-day public review from July 6 through August 5, 2016.
- SCAG staff was reviewing the Draft Guidelines and would provide comments if needed.

4.5 EPA Update

Wienke Tax, EPA Region 9, reported that South Coast Final Clean Data Determination for 1997 PM_{2.5} NAAQS was published in Federal Register on July 25, 2016

4.7 Air Districts Update

Jack Cheng, SCAQMD, reported that Draft 2016 South Coast AQMP was released on June 30, 2016 for public review and anticipated to be finalized in late November or early December 2016.

Ben Cacatian, VCAPCD, reported that Draft 2016 Ventura County AQMP was anticipated to be released in September 2016.

Monica Soucier, ICAPCD, reported the following:

- ICAPCD had been working with ARB on 2012 annual PM_{2.5} standard SIP which will be due to U.S. EPA in October 2016.
- ICAPCD had also been in collaboration with ARB in evaluating different options for Imperial County to demonstrate attainment with 2008 8-hour ozone standard. Imperial County Ozone SIP is due to U.S. EPA on January 1, 2017.
- ICAPCD had been working on a revision to its 2009 PM₁₀ SIP based on 2013 and 2015 PM₁₀ data and planned to submit SIP revision by end of 2016.

Rongsheng Luo, SCAG, acknowledged Greg Nord, OCTA, for his effective leadership and significant contribution as TCWG Chair over last twelve months.
